New League Play Format is Schedule to Start in May

For the 2002 season we plan to introduce a league play format which will begin Wednesday, May 1st thru August 21. The league will only record net scores and will be divided into three flights (A, B & C). Members will be placed in flights based on their 2001 year end handicap. If possible we will try to keep the flights equal in numbers. Once you are assigned to a flight you will remain in the flight throughout the season. League standings will be calculated on your ten best net scores, so the more rounds you play can prove to be an advantage. Standings will be posted weekly, it is important that you check your scores and inform the tournament committee of any error or omission. At the end of league play in August the first four players in each flight will qualify for the Match Play Tournament. In the event of a fourth place tie there will be an 18 hole playoff. The remaining members will be placed in a separate tournament similar to those held in past years. The winners of the Match Play Tournament will be declared Club

Champions where as the second tournament winners will be declared Tournament Champions. Prize Funds will be reviewed by the Board of Governors and it will be published when it is made official.

The sweeps will be run same as in the past, only on weeks where applicable. Also, there will be four special tournaments. The four man best ball scrabble was highly successful last year so the committee will look into running more of that type of a tournament. Same will apply to our Outings.

There will be two cash prizes awarded each week for closest to the pin, on one of the par three's on the front nine and on one of the par three's on the back nine.

The goal of the Tournament Committee is to have a program that will be competitive, fun and relaxing for all. Therefore we ask for your cooperation especially on Wednesday mourning—please be punctual, keep us informed of any change in your weekly availability and respect our dress code.
