One of the goals this year is to be more efficient in our weekly check-in procedure. Discussions have been going on to have the picking of bingo balls replaced with an easier system to set-up and schedule of foursomes.

# Match Play Winners Are To Compete For The Overall 'Club Champion'

Since the start of our League Play program and the Match Play Championship the idea of having a playoff between the winners of Flights A, B and C to determine an overall Club Champion came to light. At our year-end Board of Governors meeting one of the hot issues was what to do to make the League Play format exciting and competitive. For starters it was decided that the highest handicap a member can have was changed from 36 to 38. This conforms to the USGA standards for the slope and rating indexes of Clearview Golf Course. Second, the handicaps that form the Flights A. B and C were adjusted as follows: Flight A would range in handicap from lowest 13 to a high of 21, Flight B-22 to 30 and Flight C-31 to 38. This would group members in each flight within 8 or 9 strokes of each other. The Board of Governors favored changing the qualifications for each flight so that there would be a more balanced distribution of players and good competitiveness within each flight. Third, there will be sixteen weeks of league play. League will begin on April 28 and end on August 18th, 2004. The best ten league scores will be used to qualify members for the

'Match Play Tournament'. In the event of a tie among any of the top eight finishers an eighteen-hole playoff will be required. Fourth, the Match Play Tournament will be conducted the same as 2003. The top eight finishers in each flight will compete for the championship. Finally it was decided to have the first place winners of Flight A, B and C compete for an overall Club Champion. This is something that never has been attempted before and this year it will be presented as a trial basis. The Championship round will be Stroke Play (Net Score) one round Playoff. However, the finalist will be required to score the total number of strokes taken to hole out after each hole. Therefore the stroke maximum after each hole (four over par) will not apply during this round. Granted that a high handicap player will have an edge if he scores an average round. This would require the lower handicap players to do better than average to win. In essence, to be crowned as the overall Club Champion must rise to the challenge. The prize fund will be adjusted to conform to the new format.

Our goal is to plan an exciting finish to an exciting season.

# **Tournaments & Prizes:**

The year-end **Club Tourna-ment** will be eligible to all members that did not qualify for the Match Play Playoff. The Club Tournament will be a two-week event similar to those held in the past years.

The prize fund for the Club Tournament and the Special Tournaments will be announced at a later date. Tiebreakers in the Match Play Tournament will be decided by a sudden death playoff. Tiebreakers in the Club Tournament will be decided by a matching of holes starting with the first hole. May Special Tournament will be a two-man team total net score event. October Special Tournament will be a fourman team best ball scramble event. Sweeps will be run most of the weeks during the season when applicable. Closest to the pin the plan is to conduct them every week on one of the par threes on the front and one of the par threes on the back with a \$5.00 prize going to the winners.

For this to be a fun season we need your patience and cooperation. On Wednesday mornings please be punctual and keep us informed of any change in your weekly availability.


# **Proposed Budget 2004**
